- A collective bargaining agreement between the Frankfort School District #157-C Board of Education and the Frankfort Teacher's Association, as exclusive bargaining agent for all certified teaching staff in the district, for 2007-2012.
- There are 14 personal service contracts between various individuals and the school district in excess of \$25,000 per year for certified administrative and certified special other/non-teaching staff who are not represented by any union or exclusive bargaining agent, or covered by any collective bargaining agreement.
- There are 33 personal service contracts between various individuals and the school district in excess of \$25,000 per year for non-certified support staff who are not represented by any union or exclusive bargaining agent, or covered by any collective bargaining agreement.
